- Successful CGL and D&O insurance coverage resolution where a public entity claimed a product manufactured concerning water purification failure to perform correctly increased the likelihood of a cancer-causing chemical, approximately \$15 million exposure.
- Successful D&O coverage resolution claim of the malfunction of a water purification product at a public entity in France (under U.S. coverage law) where exposure was in excess of \$10 million.
